Strengthening Public Health

alPHa's statement of principles: (excerpt)

That regardless of the sources of funding for public health and Ontario, mechanisms must be included to ensure that the total funding envelope is stable, predictable, protected and sufficient for the full delivery of all public health programs and services whether they are mandated by the province or adopted to serve unique local needs as authorized by the Health Protection and Promotion Act, 1990.



Draft 2024 OPHS Highlights

- Still in consultation phase needs to fit with funding model review and any accountability framework revisions.
- Reflects needed level of local public health practice:
 - Increased emphasis on collaboration, engagement and partnerships including specific draft Relationship with Indigenous Communities protocol.
 - Stronger upstream focus of "primordial prevention".
- Ongoing concern about current capacity and resources.
- Need stable, predictable and sufficient funding to meet requirements.

We monitor data in four key areas:

- Naloxone distribution in our communities,
- Emergency medical service 911 calls for opioid poisonings,
- Emergency department visits for drug poisonings, and
- Deaths caused by opioid or other drug poisonings.





Last 12 months (July 2023 to June 2024)

on average a person died from a drug poisoning



74 people died from drug poisonings

Opioids



We want to 'Solve the Crisis' together, today we are requesting that the provincial government:

- Appoint a responsible ministry and Minister with the appropriate funding and powers as a single point of contact to address the full spectrum of housing needs as well as mental health, addictions and wrap around supports.
- Have this Minister strike a task force with broad sector representatives including municipalities, healthcare, first responders, community services, the business community and the tourism industry to develop a Made in Ontario Action Plan.
- Provide municipalities with the tools and resources to transition those in encampments to more appropriate supports, when deemed necessary
- Commit to funding the appropriate services these individuals need, community by community where there are gaps in the system.
- Invest in 24/7 Community Hubs / Crisis Centres to relieve pressure on emergency centres and first responders











Voluntary Mergers





The Boards of Health for the <u>Haliburton, Kawartha, Pine Ridge (HKPR) District Health</u> <u>Unit</u> and <u>Peterborough Public Health (PPH)</u> announced that they will seek provincial approval and funding to voluntary merge.

In August 2023, the Ministry of Health <u>announced plans to strengthen the public health sector</u> by offering one-time funding, resources and supports to local public health agencies that decide to voluntarily merge by January 1, 2025.

Public Health Needs:

38

- 1. Province to approve these mergers to allow for mergers by January 1, 2025.
- 2. Need the full 3 year commitments as promised by the Ministry to support the mergers.

- Thank you to AMO, alPHa and Ontario Boards of Health for the opportunity to speak regarding the voluntary merger opportunities to improve efficiencies and enhance public health programs and services.

History

- Previous efforts referred to as Modernization to reduce the number of boards of health from 36 to 10
- Terminated due to the COVID-19 Pandemic



New Initiative

- Ministry of Health initiated a voluntary merger opportunity in the fall of 2023
- Boards that wished to consider a merger were encouraged to prepare a Business Case and submit it by April 2, 2024
- Proposed implementation date is January 2025
- Criteria: Population base of 500,000+, no loss of frontline jobs, no reduction in local public health service delivery and funding considered based on a successful Business Case and Ministry of Health approval



Board Chairs Explore Feasibility of a Merger

- HPEPH and KFLAPH has a history of working collaboratively
- KFLAPH and LGLDHU has a history of working collaboratively
- Medical Officers of Health of the three health units have a relationship and work interactively
- Board Chairs and Medical Officers of Health met informally to discuss a 3-way merger and determined to go forward
- Motions were presented to each Board seeking approval to go forward and explore the option of merging



Board Chairs Explore Feasibility of a Merger

- Significant research and development of case scenarios was carried out by staff within the framework of the various boards
- Presented options to each Board with recommendation to "examine the prospect and feasibility of a 3-way merger"



Tri-Board Merger Team

- Meetings were scheduled and held on a rotating basis at the three health unit locations
- Meetings were conducted in accordance with the Municipal Act
- Terms of Reference were created
- Host Board creates the agenda, records minutes and chairs the meeting
- Special meeting with Dr. Moore and staff; update meetings have occurred with Ministry staff when required



Tri-Board Merger Team (continued)

- Each Board chose to appoint four (4) representatives to sit at initial meetings including each Board chair
- Consultants were engaged to assist with developing appropriate documents, by-laws and identify differences and commonalities between the Boards with recommendations to consider
- Decisions would be made based on majority votes and where possible by consensus
- Legal counsel was engaged to assist with development of a Memorandum of Understanding



Tri-Board Merger Team (continued)

- Memorandum of Understanding was presented to each Board at their regular meetings and was approved
- Communications with local municipalities was identified as crucial to the success of the merger

Boards' Endorsement to Proceed

- Tri-Board Merger Team became the South East Transition Team (SETT)
- Funding strategies were developed and approved by SETT
- Delegation of Medical Officers of Health to their future roles has been determined with documents being prepared by legal advisors
- Consultants prepared documents regarding harmonization of collective agreements and staff remuneration
- Redbrick Communications assisting with communication materials to ensure consistent messaging with staff, municipalities and the public



Boards' Endorsement to Proceed (continued)

 Governance Package – certain mandatory operating by-laws are being created in preparation of a January 1, 2025 start

Success of the merger is entirely dependent on funding from the Ministry of Health
