Assertive Street Outreach is an effective service approach for actively engaging people experiencing unsheltered homelessness to promote, connect, and coordinate access to the range of supports available across the County of Simcoe's Homelessness Service System, including emergency shelter and housing and support services. Assertive Street Outreach proactively engages and responds to requests in the community for individuals in public spaces, who for example may be 'sleeping rough' or living outdoors at that moment in time (ex. sleeping in car, encampments etc.) and is focused on ending the experience of homelessness, usually for those who would otherwise be underserved in traditional settings.

Assertive Street Outreach will be delivered in accordance with Coordinated Access, County of Simcoe Outreach Standards. As the Homelessness Service System evolves, the Successful Proponent will modify service delivery as service system policies are developed, tested, and implemented by the County of Simcoe. Coordinated Access is a standardized process for intake, assessment, program eligibility, referral, and prioritization to housing and supports across Simcoe County and the successful proponent will be required to utilize the Homeless Individuals and Families Information System (HIFIS) database.

The Successful Proponent shall operate as part of the Homelessness Service System funded by the County of Simcoe. The Successful Proponent will participate in activities with the County of Simcoe as the legislated Service System Manager, together with other funded community partners to transform the County of Simcoe's Homelessness Service System. The Successful Proponent will align with evidence based best practice, the 10-Year Affordable Housing and
